Summary of Assessment Findings

Outcome 1: Mastery Target was met. 86.05% of students received a 75% or higher on the common final exam.

Outcome 2: Mastery Target was met. 100% of students received a 75% or higher on the common research case.

Outcome 3: Mastery Target was met. 91% of students received a 75% or higher on the common tax research case.

Outcome 4: Mastery Target was met. 88% of students received a 75% or higher on the common writing assignment.

Interpretation of Assessment Findings

Outcome 1: For the second year in a row, this outcome has been met. Starting in Fall 2019, due to common course numbering changes, Acct 2101, Acct 2102, and Acct 2103, our three intermediate accounting courses have been re-designed and re-aligned into two intermediate accounting courses, Acct 2125 and Acct 2103. Due to this change, the Acct 2101 and Acct 2102 Common Final Exams are being re-designed for the Acct 2125 Common Final Exam.

Outcome 2: In the prior year, this outcome also was met. The Intermediate Accounting team will continue to monitor both the grades and the assigned research case to ensure that this assessment tool continues to be a viable measure of this outcome.

Outcome 3: : In the prior year, this outcome also was met. The Intermediate Accounting will continue to monitor both the grades and the assigned research case to ensure that this assessment tool continues to be a viable measure of this outcome.

Outcome 4: This is the first year using the Acct 2520 Auditing Common Writing Assignment to measure this outcome. The Intermediate Accounting team will continue to monitor these results to ensure that this assessment tool continues to be a viable measure of this outcome.
