

## Consenting to Electronic 1098T

Support Sustainability by Opting for Only Electronic Delivery of 1098T Forms.

CNM students can now opt to receive their 1098T tax forms by electronic delivery only, eliminating the need for CNM to print copies or use U.S. mail for delivery to student residents.

Once CNM turns on the consent to Paperless 1098T option, and the first time you log into your “Student Account Center” the following statement will be displayed:


“IRS regulations state that each student who files a request to receive a 1098T electronically must also provide his/her consent electronically. By clicking on Accept Consent, you state your intent to receive your 1098T form electronically for each year that you attend Central New Mexico Community College. Furthermore, you agree to log into the myCNM student portal to print, email or save your 1098T. With this consent for an on-line electronic 1098T, please understand that a paper copy of your 1098T will NOT be mailed. If you elect not to consent, a paper copy of your 1098T will be sent to you via US Mail.

Your paperless 1098T choice can be changed at any time via the My Profiles page.”

Once you have read the statement you can choose whether you would like to consent or not consent to receiving your 1098T electronically.

If the left side menu is not visible click the  in the upper left corner.

Then Click on Pay Here, in the Make a Payment box.
